### Road Accidents in India Takes More Lives Than Any Other Developed Countries

In our country, according to official statistics 150,785 persons died and 494,624 injured in road accidents in 2016 and one of the research by the **Million Death** estimated the fatalities is about 47%-64% which is much higher than the report of the National Crime record Bureau (NCRB) and appears to be closer to the truth. It is said that over 400 people die every day in India due to road accidents which is much higher than any other developed nations.
